## **11<sup>th</sup> class of clergy renewal recipients selected to participate in Lilly Endowment program**

From Maine to Oregon, Idaho to Florida, 149 congregations will send their pastors forth for an extended time of sabbath renewal and reflection as part of the National Clergy Renewal Program, funded by the Indianapolis-based Lilly Endowment Inc. The program allows pastors to step back from their busy lives and gain the fresh perspective and renewed energy that a carefully considered season of travel, study, rest and prayer can provide.

Many of the pastors will venture far from their home grounds to visit the Holy Land or other places of familial or religious significance, to join colleagues who are engaged in ministries and missionary work elsewhere in the world, to hone their skills in music, writing and the arts, or to engage in theological study and spiritual retreats.

Two pastors will literally go to the ends of the earth. One will make a photo voyage to the Arctic wilderness; another will follow the route taken by legendary polar explorer Ernest Shackleton from England to South Georgia, Antarctica, in 1914.

The pastors are members of the 11<sup>th</sup> class in the National Clergy Renewal Program, and they bring to 1,440 the number of congregations that have participated since the program began in 2000. Through this program, the Endowment invites Christian congregations to apply for grants of up to \$50,000 to support an extended period of intentional reflection and renewal for their ministers. The ministers, working with their congregations, design their renewal periods to suit their own needs and aspirations. The pastors are encouraged to include their families in the renewal activities.

Further, up to \$15,000 of the grant may be used for the congregation to pay for interim pastoral leadership while the pastor is away, as well as for renewal activities within the congregations.

“The intensity and demanding character of pastoral work in most congregations is difficult for many to appreciate,” says Craig Dykstra, senior vice president for religion at the Endowment. “They write and preach sermons, make hospital visits, administer the ‘business’ of their churches, preside at weddings and funerals, and counsel parishioners. And they are expected to ‘be there,’ to be available at both the best and the worst times in people’s lives.

“The National Clergy Renewal Program gives pastors the gift of being able to live for a while at a different pace and in an alternative environment – to live in Sabbath time and space, and to honor that moment as God-given,” Dykstra says. “Many clergy renewal participants have reported to the Endowment that when they returned they found their vision for ministry enlarged and their call and commitment renewed.

“We find that these programs can be transformative for the congregations, too,” Dykstra continues. “Not only do members of these congregations grow in their leadership abilities in the pastor’s absence; they also learn how to create an environment at their churches that supports their pastor’s continued service at a pace that he or she can sustain. Many of them discover ways to renew and refresh their own lives and spirits as well.”

This year’s group includes congregations located in 40 states and the District of Columbia; they are affiliated with 11 different denominational bodies. Nearly half the grantees see between 100 and 400 at worship on Sundays; eight report worship attendance of 1,000 or more. The oldest church – First Presbyterian Church of Smithtown, Pa. – traces its heritage back to 1675 when the first meeting house was built. The newest congregation – Living Water Christian Church in Parkville, Mo. – first “congregated” on Easter Sunday 2004.

What these pastors choose to do with their three- or four-month “gift of time” varies widely. Next summer more than 20 pastors will embark on journeys to biblical sites to participate in archaeological digs, go on pilgrimages to Jordan and Egypt, or trace the footsteps of St. Paul in Greece and Turkey. Twenty-nine more pastors will head for Africa to visit churches, teach in seminaries, work with orphan children – or with orphaned lion cubs.

Storytelling and story collecting are also important themes for renewal programs. This year one pastor will attempt a family reconciliation and then write about it. A Mississippi pastor,

whose parish was destroyed by Hurricane Katrina in 2005, hopes his workshops on the Sabbath and journal work will equip his parishioners to tell their Katrina stories. A pastor of Filipino descent will write an ethnic heritage reflection handbook for his congregation, and an Ohio pastor will follow the path of African slaves from sites of bondage to routes of freedom.

Many pastors love music and the arts, and the renewal program gives them the leeway to indulge this passion. One will receive professional instruction in blues guitar so he can write songs based on the psalms of lament in the Bible. Another, once a prolific composer of sacred music, will have an uninterrupted period of time to compose again. One pastor will sing at the Berkshire Chorale Festival. Another will visit sites associated with his “three B’s” – Bach, Beethoven and the Beatles.

Other pastors will take art classes, view the masterpieces of Europe, or attend writers’ conferences and retreats. Another pastor will visit Russia to explore the craft of iconography.

Many pastors find the renewal time an excellent time to get fit – and learn how to stay that way. One will train for a marathon while others will hike the Appalachian Trail or trails in various national parks. One will walk the 500-mile el Camino de Santiago (“the way of St. James”), an ancient pilgrimage route in Spain. Several want to learn to grow, prepare and cook healthy foods.

Typically, many pastors will make spiritual retreats in places of renowned hospitality for meditation and contemplation. This year’s pastors will travel to Iona, Taize, the labyrinth at Chartres and other contemplative retreat centers in the United States, Europe and South Africa.

All these renewal programs exhibit the basic thrust of the Endowment’s program: a chance for congregations and ministers to engage in renewal of a kind that will have important impact on their churches, their individual members and their communities.

“The wealth of imagination unleashed by this program is truly wonderful to see,” says the Endowment’s Dykstra. “We can think of no better way to honor these hardworking, faithful men and women than to help them experience personal growth and renewal in ways that they themselves believe will feed them most deeply.”
